OFFICIAL RULES

1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

2. EACH SWEEPSTAKES ENTRY WILL HAVE AN EQUAL CHANCE OF WINNING. MAKING A PURCHASE WILL NOT IMPROVE AN INDIVIDUAL ENTRY'S CHANCES OF WINNING.

8. Additional Rules Applicable to On-Line Entries: On-line entries using macro, robotic, script or other forms of automatic entry will be disqualified. Proof of submission does not constitute proof of receipt. The Credit Union is not responsible for late, incomplete, or inaccurate entries. If there is a dispute as to the identity of an on-line entrant, the prize will be awarded to the authorized account holder of the e-mail address. The "authorized account holder" is defined as the natural person to whom the e-mail address is assigned by an internet service provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. The Credit Union is not responsible for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry information by the Credit Union on account of technical problems or traffic congestion on the Internet or at any Website or any combination thereof. - 14. **NOTICE OF BINDING ARBITRATION AGREEMENT**: You and we agree to attempt to informally settle any disputes arising out of or connected with this Sweepstakes or any prizes awarded. If that cannot be done, you and we agree that upon the election of either you or us any claim or dispute arising out of or connected with this Sweepstakes will be resolved by **BINDING ARBITRATION** administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules and Mediation Procedures and Supplementary Procedures for Consumer-Related Disputes. As a result, you will GIVE UP YOUR RIGHT TO GO TO COURT to assert or defend your rights under these Official Rules (EXCEPT for matters within SMALL CLAIMS COURT jurisdiction). You acknowledge that by agreeing to **BINDING ARBITRATION** you understand and agree to the following terms:
 - Your rights will be determined by a NEUTRAL ARBITRATOR and NOT a judge or jury. You understand and agree that <u>YOU ARE WAIVING THE RIGHT TO</u> <u>A TRIAL BY JURY.</u>
 - Arbitration proceedings provide you a **FAIR HEARING**, BUT the arbitration procedures are **SIMPLER AND MORE LIMITED** THAN RULES APPLICABLE IN COURT.
 - Arbitration decisions are as enforceable as any court order and are subject to <u>VERY</u> <u>LIMITED REVIEW</u> BY A COURT.
 - ARBITRATORS can award the same REMEDIES including DAMAGES that a COURT can award.
 - Any ARBITRATION under these Official Rules <u>WILL BE ON AN</u> <u>INDIVIDUAL BASIS</u>. You understand and agree that <u>YOU ARE WAIVING</u> <u>THE RIGHT TO PARTICIPATE AS A CLASS REPRESENTATIVE OR</u> <u>CLASS MEMBER IN A CLASS ACTION</u>.
 - The PLACE OF ARBITRATION shall be in the federal district WHERE YOU RESIDE.
 - WE WILL REIMBURSE YOU FOR ANY FILING, ADMINISTRATION, AND ARBITRATOR FEES as imposed by the American Arbitration Association. However, if the arbitrator determines that YOUR CLAIM IS <u>FRIVOLOUS</u>, <u>UNWARRANTED, OR BROUGHT FOR AN IMPROPER PURPOSE</u> (in accordance with the Federal Rules of Civil Procedure Section 11(b)) YOU WILL RETURN TO US ANY FILING, ADMINISTRATION, AND ARBITRATOR FEES WE PAID.
 - If YOU PREVAIL on the merits of your claim in arbitration, WE WILL PAY YOUR ATTORNEYS' FEES. You will NOT be required to pay OUR ATTORNEYS' FEES IF WE PREVAIL.

15. **Privacy/How We Use Your Information:** Sponsor will collect personal data from entrants solely for Sponsor use, and this information may be used for the purposes of
