
Tell us about your vision for an educational program, project, or service in 2021. What do you hope to accomplish? Who will benefit? How much will it cost to make your dream a reality?

Application eligibility

- Current pre-kindergarten educators
- Current K-12th grade teachers

Application requirements

- Contact information
- Summary of program or project
 - Budget (if applicable)
 - Timeline
 - Project outline
- Note: winners must provide an impact summary by Dec 2, 2021 for internal audit purposes



How are submissions evaluated?

Applicants will be scored using this criteria:

- Creativity
- Number of students engaged
- Financial need (if applicable)

Application timeline

- Apply online at kinecta.org/teaching-grants
- Application period is Feb 15 Mar 15, 2021
- Applications must be received by Mar 15, 2021
- Winners will be announced by the end of May 2021
- Grant funding will be awarded by Aug 31, 2021

- Supplemental instruction
- Funding creative classroom projects
- School supplies
- Other educational purposes

Applications will be scored by a Kinecta grant oversight committee. Project summary and application must be submitted in English.

Applications must be received by March 15, 2021. Kinecta teaching grant winners will be announced on or around May 31, 2021. Funds will be paid on or around August 31, 2021.

Each winner agrees to permit Kinecta to use his/her name and likeness in promotional and other Credit Union materials, without additional compensation or permission, except where prohibited by law. Winners will be asked to provide an impact summary by December 2, 2021.

Applicant agrees to accept the decisions of Kinecta as final. Past Kinecta teaching grant winners, Kinecta and its subsidiaries' employees, volunteers, and their immediate family members are not eligible.
