Kinecta Car Sale HD TV Sweepstakes May 2017

- 1. The Kinecta Car Sale HD TV Sweepstakes May 2017 Sweepstakes ("Sweepstakes") begins at 9:00am (PST) May 20, 2017 and ends 8:00pm (PST) May 21, 2017 ("Sweepstakes Period"). To Enter Automatically: Event attendee must submit a completed Sweepstakes Entry Form during event hours to a Kinecta representative during the Sweepstakes Period. Event attendees will receive one (1) sweepstakes entry during the Sweepstakes Period. - 2. Sweepstakes Drawing: One (1) drawing will be held following the Sweepstakes Period on or around May 26, 2017. The winner for the drawing will be announced following the drawing period on or around May 29, 2017. Handwritten entries must be received at the Credit Union by Sunday, May 21 at 8:00 p.m. PST to be eligible for the drawing. The winner will be notified by phone and/or email and by mail after acceptance of the prize.
- 3. Prize: The prize will consist of a high definition television (HD TV), which has an approximate purchase value of five hundred dollars (\$500.00). Odds of winning are approximately 1 in 650 for the prize drawing, however actual odds of winning depend on the number of eligible entries received. Winner cannot substitute, assign, or transfer the prize, except at the sole discretion of the Credit Union. The winner will have 10 business days to respond to Kinecta in order to claim their prize. In the event that a winner does not respond to the contact attempts from Kinecta within 10 business days of the first attempt, the winner will forfeit their right to the prize and a replacement winner will be randomly selected from the remaining eligible entries. The prize will be available for pickup at the Kinecta Federal Credit Union location 1440 Rosecrans Avenue, Manhattan Beach, CA 90266. In the event that the winner cannot pick up the prize at Kinecta's location, any shipping costs and arrangements for prize delivery are the responsibility of the winner. If the winner fails to pick up the prize or arrange shipping within 10 days of accepting the prize, the winner will forfeit the prize and a replacement winner will be randomly selected from the remaining eligible entries.
